

2018 PULSE Permission Slip

Both sides to be completed by a legal guardian of the listed youth.

We strive to keep our activities as fun & safe as possible in order to provide an exciting and beneficial environment for everyone who attends. In order to do so, we need your consent on a few things. Please **initial** in the box to the left of each statement if you agree and adhere to its terms concerning the listed youth during any Pulse sponsored events.

Pulse can send home any youth at any time...if any of the following is observed from him/her: any rude or disrespectful language or behavior, posing a threat, or anything that we deem inappropriate. The guardian will be notified and transportation will need to be worked out between the guardian and the teen.

Pulse is not liable for any lost, broken or stolen items.
Eg: phones, Ipods, chargers, school ids...you name it.

Pulse is not liable for any harm that comes upon the youth during Pulse sponsored activities. There will be games & events that require some level of physical activity. Proper safety instructions & equipment will always be provided to help prevent harm. If a teen doesn't follow or comply with any part of these instructions or equipment, there is potential that they can hurt themselves as well as others.

Pulse isn't liable for any food-related issues including, but not limited to, choking, food allergies, and consuming raw or undercooked items.

OPTIONAL: I give this youth permission to walk home from First Baptist Church after Pulse sponsored events?
Some teens live close enough and some guardians allow their teen to walk home. We cannot protect them during their walk home & can't be held liable for any harm that may fall upon them. *(Does not include children who attend AWANA)*

OPTIONAL: Pulse can provide proper transportation* to local and surrounding destinations for events.

Please place a checkmark next to the locations you are allowing your teen(s) to be driven to.

Local - this is limited to destinations within Freeport.
(eg: Lindo Movie Theater, Union Dairy, Krape Park, Four Seasons Bowling Alley, various restaurants, etc.)

Surrounding - any place that is within one hour of Freeport. (Eg: Rockford, Lena, & Pearl City)

* By allowing Pulse to provide transportation, you make exempt and relieve First Baptist Church and Pulse Youth Ministries (its staff & members) from liability of personal injury, property damage, or wrongful death of the youth listed.

NOTE: Larger-scale activities that we deem appropriate for extra consent or are located more than one hour away from Freeport will require an extra permission slip that will need to be signed and returned before the activity takes place. Those slips will be provided at least one week prior to the event.
